Section 1. The salary of the Yates County District Attorney shall be increased by the amount stipulated in the grant awarded to Yates County by New York State pursuant to the Aid to Prosecution Grant.

Section 2. In any year in which funds from New York State's Aid to Prosecution Grant are not awarded to Yates County, the salary of the District Attorney shall revert to what it would ordinarily be pursuant to Yates County Legislature Resolution No. 232-99.

Section 3. In any year in which funds from New York State's Aid to Prosecution Grant are not awarded to Yates County, any increase in the District Attorney's budget made in anticipation of said grant money shall be revoked.

Section 4. Insofar as the provisions of this local law are inconsistent with the provisions of any other local law or act, the provisions of this local law shall be controlling.

Section 5. This Local Law is adopted subject to a referendum on petition and shall take effect thereafter subject to applicable provisions of the Municipal Home Rule Law. This Local Law shall take effect in accordance with the provisions of Section 24.
