- Section 1. Section 922 of the Real Property Tax Law provides the form and content of the Town and County tax bill to be mailed by the collecting officer in each town showing the amount of taxes due on each property.
- Section 2. The Yates County Legislators desire to show the true costs of county government for Medicaid expenses, which are mandated by the State of New York, yet not reimbursed by the said state.
- Section 3. Pursuant to Section 922 of the Real Property Tax Law, the county tax rate for 2003 shall be separated into two parts, one for the general county budget and the second for unreimbursed Medicaid expenses.
- Section 4. This local law shall take effect upon filing in the Office of the Secretary of State as provided by Section 27 of the Municipal Home Rule Law.
