A local law Authorizing the Chairman Of The Board Of Supervisors Of The County Of Yates To Approve Attendance AT Conventions, Conferences And Schools By Officers Or Employees Of The County.

SECTION 1: That pursuant to Section 77-b of the General Municipal Law, the Chairman of the Board of Supervisors is hereby authorized to approve the attendance of officers or employees of Yates County at official or unofficial conventions or conferences or any school conducted for the betterment of municipal government.

SECTION 2: That this Local Law shall take effect the twentieth day after it shall have been adopted and after a public hearing, as required by Section 304 of the County Law.
