A local law of the County of Yates to place eligible Sheriff's Department

Section 1. Legislative intent.

The purpose of this Local Law is to place eligible Sheriff's Department employees under the classified service of New York Civil Service Law.

Section 2. Short title.

This Local Law shall hereafter be known as the Yates County Sheriff's Department Civil Service Law.

Section 3. Deputies and Employees.

All deputies and employees of the Sheriff of Yates County except the Undersheriff, the secretary to the Sheriff by whatever title designated, and his Civil Deputies are hereby placed in the classified service of the Civil Service Law of the State of New York, in the competitive class unless placed in a different class by determination of the Yates County Civil Service Commission.

Section 4. Applicable Law.

The offices and positions of all such deputies and employees in the classified service shall be subject to and governed and controlled by the Civil Service Law and the rules and regulations of the New York State Department of Civil Service.

Section 5. Exception.

Notwithstanding the provisions of the foregoing, however, all employees of the Sheriff, except the Undersheriff, the secretary to the Sheriff and his Civil Deputies, who have served for one year or more in their respective positions prior to the effective date of this Local Law, shall be covered in their respective positions without examination.

Section 6. Effective Date.

This Local Law shall take effect on the 1st day of May, 1977.
