Section 1. The County Treasurer is authorized pursuant to Section 22 of the General Municipal Law and Section 331 of the Insurance Law to file a claim against the proceeds of a fire insurance policy for County real property tax liens.

Section 2. The insured may have said lien released or the proceeds returned provided the insured agrees with the County in writing to restore the affected premises to the same or improved condition that it was in prior to the time that the lien of the County arose and further provided that said sums be held in an escrow account until the improvements have been completed or until the insured shall obtain a performance bond insuring the completion of said improvements.

Section 3. This local law shall take effect immediately.
