Section 1. The Sheriff of Yates County, upon receiving a person committed to the Yates County Correctional Facility as an inmate, shall determine by questioning such person or by other procedures, if the person carries third party coverage or indemnification for services received from a hospital, doctor or dentist, required to be provided to on inmate by Section 500-h of the Correction Law of the State of New York.

Section 2. If the inmate has such coverage, the Sheriff of Yates County shall seek reimbursement for all services, medical or dental, rendered to such inmate as required by said Correction Law.

Section 3. This Local Law shall take effect immediately.
