SECTION 1: Local Law No. 2 of the year 1984 if the County of Yates is hereby repealed.

SECTION 2: Pursuant to Real Property Tax Law Section 458-a(2) (d) (ii), the exemptions from real property taxes provided by paragraphs (s), (b) and (c) of subdivision 2 of Section 458-a are hereby reduced to nine thousand (\$9,000.00) six thousand (\$6,000.00) and thirty thousand dollars (\$30,000.00), respectively.

SECTION 3: This local law shall take effect upon its filing with the Secretary of State, but pursuant to Real Property Tax Law Section 458-a, the exemptions provided shall not be available until the 1996 taxable year.
