Be it enacted by the County Legislature of the County of Yates as follows:

Section 1. There is hereby created and established the Office of Deputy County Superintendent of Highways for the County of Yates.

Section 2. The Yates County Superintendent of Highway shall appoint a Deputy County Superintendent of Highways, with the approval of the County Legislature, for such periods or periods as the Legislature may determine, but limited to the term of office of the Superintendent making the appointment. The Superintendent shall have the power and authority to terminate such appointment at this pleasure.

Section 3. During any absence of the County Highway superintendent which prevents him from performing the powers and duties of the office granted by Section 102 of the New York State Highway Law, the Deputy Highway Superintendent is authorized to act generally for and in place of the Highway Superintendent.

Section 4. The Legislature shall determine the amount of such Deputy's bond and fix his salary and provide for the payment of all the necessary expenses incurred while in the performance of his duties, which salary and expenses shall be a charge against the county road fund, and may remove him from office for such causes in the same manner as provided for the removal of a County Superintendent of Highways.

Section 5. This Local Law shall take effect immediately upon filing in the Office of the Secretary of State of New York as provided in Section 27 of the Municipal Home Rule law.
