Section 1. Authority

This Local Law is enacted pursuant to section 16 of the New York State Civil Service Law which authorizes the County to elect to change the form of Civil Service Administration from a Civil Service Commission to a Personnel Officer.

Section 2. Effective Date of Election

Pursuant to section 16(2) of the New York State Civil Service Law the effective date of the change of form of the Yates County Civil Service Administration shall be one year from the effective date of this Local Law. At such time the Yates County Civil Service Commission is abolished and the Office of Yates County Personnel Officer is established pursuant to Sections 15 and 16 of the New York State Civil Service Law to administer the Civil Service Law.

Section 3. Effective Date of Law

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with the New York State Municipal Home Rule Law.
