Local Law No. 3-73 Sec. 5 (a) as last amended by Local Law No. 1-75, is hereby amended to read as follows:

Section 5. Limitations on Exemption

No real property shall be entitled to the exemption granted by this Local Law.

(a) If the income of the owner or the combined income of the owners for the income tax year immediately preceeding the date of making application for exemption exceeds the sum of \$5,000.00. Income tax year shall mean the twelve month period for which the owner or owners filed a federal personal income tax return, or if no such return is filed, the calendar year. Where title is vested in either the husband or wife, their combined income may not exceed such sum. Such income shall include social security and retirement benefits, interest, dividends, net rental income, salary or earnings and net income from self-employment, but shall not include gifts or inheritances.

This Local Law shall take effect on the 1st day of January, 1978.
