A. Project and Sponsor Information

Brief Description of Proposed Action

The Waterfront Revitalization/Redevelopment Project ("Project") consists of proposed actions undertaken by three (3) parties in the vicinity of the Keuka Lake Outlet, namely, the Village of Penn Yan (the "Village"), Keuka Outlet Development LLC ("KOD") and Yates County.

The Village proposes to extend sanitary sewers to parcels within an area of the Village that are not currently served by existing sewers, to replace existing sanitary sewers on Monell, Hicks and Waddell Streets to address infiltration and inflow ("I&I") issues, and to construct two (2) pump stations, one at Hicks Street and the other on the Monell Street sewer line. Approximately 800 linear feet of sanitary sewer will be installed parallel to the Keuka Lake Outlet in a former railroad right of way owned by the Village. After installation, a nature trail is proposed to be constructed on the right of way. All activities will occur in an area roughly bounded by Lake Street to the south, Monell Street to the east, the Keuka Lake Outlet to the north and Mace Street to the west. Existing water lines located beneath Lake Street (NYS Route 54) will also be replaced (replacement in kind). Many of the activities are, at least in part, being proposed to facilitate future development on the former Penn Yan Marine Manufacturing Corporation site (the "Site").

Initially, the Village intended to conduct a SEQRA review that was limited to the activities described above. This was because no proposal for development on the Site existed. However, recently, KOD has expressed a desire to develop the Site with townhomes and a boat basin. To the extent feasible, this Full Environmental Assessment Form considers the Village proposals, the Yates County proposal and the KOD proposal at the Site as a single Project.

Yates County is the owner of the Site, which has been accepted into the New York State Department of Environmental Conservation ("DEC") Brownfield Cleanup Program (Site No. C862005). On August 4, 2014, the DEC approved an amendment to add KOD as an applicant to the Brownfield Cleanup Agreement. Pursuant to a written Development Agreement dated February 26, 2014 between the County, Village and KOD, the County will convey title to the Site to the Village, and the Village will immediately convey title to the Site to KOD. KOD will enter into a PILOT agreement with the Yates County Industrial Development Agency ("IDA") and will transfer title to the IDA and lease the Site back. KOD will remediate the Site. Following remediation of the Site and issuance of a Certificate of Completion, KOD proposes to construct condominiums, a boat basin and ancillary site improvements to support the development. The County's obligation regarding the development of the Site pursuant to the above-referenced Development Agreement includes the transfer of title to the Village, as well as the provision of in-kind services for certain infrastructure

improvements, payment of engineering costs associated with remediation and environmental monitoring.

Village construction on sanitary sewers is anticipated to commence in Fall 2014 and be complete in 2015. Commencement of construction on the KOD residential townhome project and ancillary activities is dependent upon completion of the Brownfield Cleanup Program ("BCP") for the Site and issuance of a Certificate of Completion. Remediation of the Site constitutes the first phase of the KOD development activities, and it is expected that completion of construction will occur in 2018.

D.2 Project Operations

d. Liquid Waste

As indicated in the Project Description, the Village proposes to extend sanitary sewers to parcels within an area of the Village that are not currently served by existing sewers, to replace existing sanitary sewers on Monell, Hicks and Waddell Streets to address I&I issues, and to construct two (2) pump stations, one at Hicks Street and the other on the Monell Street sewer line. These improvements are necessary to provide adequate sewer service to nearby parcels that are proposed to be developed on the Site.

Existing Conditions – Capacity. The sanitary sewer flows being projected for the Project are set forth in the August 2009 "*Utility Assessment for the Village of Penn Yan*" prepared by Hunt Engineers (the "Assessment"). The Assessment estimates the sanitary sewer flow ranges from 26,000 gpd to 41,000 gpd. At 41,000 gpd the peak hourly demand would add 115 gpm to the sewer system along Lake Street. The current capacity of the Lake Street sewer is estimated at 1,297 gpm.

The Town of Jerusalem pump station has the capability of pumping 350 gpm, which discharges into the manhole at Lake Street and Hicks Street. The Milo force main has the capability of pumping 273 gpm, which discharges into the Lake Street sewer in the Monell Street and Kimble Avenue area. The total estimated Village peak hourly flow through the Lake Street sewer line is 422 gpm. Collectively, the pumping capacity of the Village, Jerusalem and Milo results in a peak hourly flow of 1,045 gpm, which is 242 gpm less than the capacity of the Lake Street sewer line. Therefore, at the present time, sufficient capacity exists in the Lake Street sewer to convey flows from the proposed development. However, the Assessment also indicates that I&I has presented concerns in the past and can significantly reduce sewer capacity.

Improvements. The improvements that are proposed to service the northerly portion of the Site consist of replacing the existing sewer on Monell Street, approximately 600 lineal feet; extending sewer to the northern boundary of the Site, approximately 700

lineal feet; and installing a pump station. This would allow the northern portion of the Site to be served by gravity sewer. The sewer replacement will also eliminate the I&I concerns along Monell Street.

The improvements necessary to service the southern portion of the Site would include a pump station and approximately 1,400 lineal feet of piping. This pump station would be located at the end of Hicks Street. This new construction would eliminate the older sewer on Hicks Street, the existing pump station at Waddell Avenue, and would also eliminate the I&I concerns along Hicks and Waddell.

The peak hourly flow from the southern portion of the Site is estimated at 49 gpm. The flow from the new pump station at the end of Hicks Street to the manhole at the intersection with Lake Street would discharge at the same location as the Jerusalem force main. The combined flow at this point would be approximately 399 gpm, with the capacity of the sewer in this area at 800 gpm. Accordingly, there is adequate capacity in this stretch of the Lake Street sewer to accept the peak hourly flow.

These proposed improvements are shown on the attached location sketch, Exhibit 1.




