**A LOCAL LAW AUTHORIZING YATES COUNTY TO INSERT INFORMATION INTO
THE TAX BILL FOR COUNTY PURPOSES**

Be it enacted by the Legislature of the

County

~~City~~ of Yates as follows:

Section 1. Section 922 of the Real Property Tax Law provides the form and content of the Town and County Tax bill to be mailed by the collecting officer in each town and showing the amount of taxes due to each party.

Section 2. It is the desire of the Yates County Legislature to provide a legal mechanism to ensure that citizens receive accurate tax bill information and county budget information.

Section 3. The Budget Officer and Clerk of the Legislature are hereby directed to take any and all action necessary to cause a Tax Bill Flyer summarizing financial information regarding state mandates to be included as an enclosure with each annual property tax bill. The Tax Bill Flyer shall include the following sections:

- a. Standard statement defining mandate.
- b. Narrative summary of key financial impacts of State mandates.
- c. A graphic illustrating mandated portions of the County budget.
- d. This information to be posted on the County website.

Section 4. The procedures required by this local law shall be carried out in addition to, and in accordance with, other annual tax billing procedures existent within the County of Yates.

Section 5. This local law shall take effect immediately upon the date it is filed in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law of the State of New York.
