Section 2. The salary for the position of Yates County Clerk for the year 1981 shall be at the annual rate of \$16,000.00.

Section 3. This Local Law is adopted subject to a referendum on Petition and shall take effect on the 31st day of July, 1980, or if a Petition be filed in accordance with New York State Municipal Home Rule Law Section 24, then this Local Law shall take effect in accordance with the provisions of Section 24.
