Section 5. Limitations on Exemption

No real property shall be entitled to the exemption granted by this

- (a) If the income of the owner or the combined income of the owners for the income tax year immediately preceeding the date of making application for exemption exceeds the sum of \$9,000.00 as per the income limit provisions of Section 467 of the Real Property Tax Law and the sliding scale provision of Section 467 of the Real Property Tax Law.
