SCHEDULE "A"

- SECTION 1. The purpose of this Local Law is to permit a person entitled to a real property tax exemption, pursuant to Section 467 of New York State Real Property Tax Law, extending the age requirement of sixty-five years of age anytime on or before December 31st, of the year they are applying provided the application is submitted prior to Taxable Status Day (March 1)
- SECTION 2. This Local Law shall apply to assessment rolls prepared on the basis of taxable status date occurring on or after March 1, 2001.
- SECTION 3. If any clause, sentence, paragraph, section or a part of this Local Law shall be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder, but shall be confined in its operation to the clause, sentence, paragraph, section or a part directly involved in a controversy in which such judgment shall have been rendered.
- SECTION 4. This Local Law shall take effect immediately pursuant to the requisites of the Municipal Home Rule Law.
