Section 1. Legislative Intent

The purpose of this Local Law is to provide for the time for fixing salaries of County Legislators and County Officers prior to the election of such Legislators and County Officers.

Section 2. Legislative Authority

This Local Law is enacted pursuant to the provisions of Article 5 of the County Law of the State of New York, as amended.

Section 3. Short Title

This Local Law shall hereafter be known as the Yates County Legislators' and Officers' Salary Law.

Section 4 . Time for Fixing Salaries

A. In any year in which any County Officer, including County Legislators, are to be elected in the November general election, then at least 60 days prior to the date of the New York State Primary Election in that year, the County Legislature shall finally fix the annual salaries to be paid to such County officers including County Legislators, during their terms of office beginning the first day of January next following the date of such general election.

B. This Local Law shall not apply to members of the Judiciary.

Section 5. Effective Date

This Local Law shall take effect on the 1st day of November, 1978.
