A local law of the County of Yates to Repeal Local Law 3-75 and to further repeal Local Law 5-76 (Insert title)

Section 1. Legislative Intent

The purpose of this Local Law is to repeal the provisions of those Local Laws heretofore enacted which are inconsistent with Real Property Tax Law Section 485-b entitled "Business Investment Exemption: Specifically, this Local Law repeals Local Law 3-75 entitled "A Local Law of the County of Yates to provide for real property tax exemption for eligible business facilities certified by New York State Job Incentive Board", and further repeals Local Law 5-76 entitled "A Local Law of the County of Yates to reduce to zero the percentage of exemption provided under Chapter 278 of the Laws of 1976 of the State of New York".

Section 2. Legislative Authority

This Local Law is enacted pursuant to the provisions of Real Property Tax Law Section 485-b.

Section 3. Provisions

The tax exemption provided by Local Law 3-75 and 5-76 are hereby repealed and the provisions of Real Property Tax Law Section 485-b are hereby adopted.

Section 4. Effective date

This Local Law shall take effect on the date on which it shall be filed with the Secretary of the State of New York.
