Section 1. Legislative Intent

The purpose of this local law is to annul the application of Chapter 278 of the Laws of 1976 of the State of New York as they apply to the County of Yates and continue the exemptions for real property tax exemption for eligible business facilities as provided to Yates County Local Law No. 3 of the year 1975.

Section 2. Legislative Authority

This local law is enacted pursuant to the provisions of Section 85-b of the Real Property Tax Law of the State of New York.

Section 3. Short Title

This local law shall hereafter be known as the "Yates County Business Improvements Partial Real Property Tax Exemptions Law".

Section 4. Provisions

The tax exemptions provided under Section 485b of the Real Property Tax Law of the State of New York shall not apply to real property located in the County of Yates, New York in respect to taxation and special ad valorem levies imposed by or on behalf of the County of Yates for county and part-county purposes. The real property tax exemption for eligible business facilities certified by New York State Job Incentive Board as provided for under Yates County Local Law of the year 1975 shall continue to be applicable.

Section 5. Effective date

This local law shall take effect on the date on which it shall be filed with the Secretary of State of the State of New York.
