A local law Providing For The Collection Of Investigation Fees By The Yates County

Section 1. The Yates County Probation Department is hereby empowered to collect fees for custody/visitation investigations pursuant to Section 252(a) of the Family Court Act.

Section 2. The fee schedule shall be as follows:

SERVICE	FEE	ADJUSTED GROSS INCOME PER PARTY:
Custody/Visitation Investigation	\$100.00	\$0 - \$15,000
	\$150.00	\$15,000 - \$30,000
	\$200.00	over \$30,000

The fee is based on ability to pay and may be waived at the discretion of the court if the parties lack sufficient means to pay the fee.

No fee shall be charged for any investigation in which the Department of Social Services is named as Petitioner or Respondent.

Section 3. The procedure for the collection of such fees shall be as prescribed by the appropriate laws of the State and any amendments thereto or as determined by the Yates County Probation Director where the State has not enacted procedures.

Section 4. The fees set forth in Section 2 of this local law may be amended by resolution of the Yates County Legislature.

Section 5. This local law shall take effect immediately upon the filing of same pursuant to Section 27 of the Municipal Home Rule Law.
